Dear Sir,

This is to inform you that the XXI All India Kumar Surendra Singh Inter School Shooting Championship 2017 in Air Weapon events will be held at Sunbeam Academy, Varanasi from 2nd to 8th October 2017. It will be conducted by the U.P. State Rifle Association under the patronage of NRAI, as per the program attached. Shooters from schools all over the country are invited to participate in this Championship. The terms and conditions are as under:-

1. The competition is open to school students all over the country in individual and team events subject to terms and conditions as laid down in NRAI's circular No. TRG/MATCH BOOK/232/98 dated 28th December 1998 and as amended on 24th May 2002 by Governing Body of NRAI and circulated as per our letter No. TRG/ MATCH BOOK/232/02 dated 7th June 2002.
2. Students will represent their Schools through respective State Rifle Associations.
3. All the affiliated units are advised to send copy of the result books for state level inter School Shooting Competitions conducted by them to verify the scores as stated in serial No. 12 of our circular dated 7th June 2002 as under :-

4. The entries duly signed by the President/Secretary of affiliated units of NRAI only will be accepted. An entry form is attached herewith for your use. The entry forms duly completed stating Shooters ID number should be sent to this office along with entry fees so as to reach this office on or before **11-09-2017**.

Late entry with triple entry fee will be accepted up to 18-09-2017. The entry fee should be remitted by cash/money order or by bank Draft in favor of THE NATIONAL RIFLE ASSOCIATION OF INDIA. Kindly note that cheques will not be accepted. The list of matches and entry fee is enclosed herewith for your necessary action.

The State Rifle Associations/Units will be imposed a penalty of Rs. 3000/- per Shooter in case their shooters score below 15% of the Qualifying Score as per NRAI Match Book Rule 1.4 during XXI All India Kumar Surendra Singh Inter School Shooting Championship 2016. The State/Unit must deposit the penalty amount with NRAI immediately otherwise shooters from the Unit/State will not be allowed to participate in any competition conducted by NRAI. The Secretary General, NRAI may also call for explanation of the Unit/State for sending such shooters. Shooters participating in XXI All India Kumar Surendra Singh Inter School Shooting Championship 2016 on the basis of their performance during any competition conducted by NRAI shall be exempted.

A penalty of Rs. 200/- will be charged if a shooter loses his/her competitor card/equipment control sheet during the competition. Fresh Card / Equipment Control Sheet will only be issued on the payment of penalty.

IT IS MANDATORY FOR ALL SHOOTERS TO GET THEMSELVES REGISTERED WITH NRAI AND OBTAIN SHOOTER ID CARD (IF NOT ALREADY DONE). THE REGISTRATION FORM IS ALSO AVAILABLE ON OUR WEBSITE www.thenrai.in THE REGISTRATION FEE IS RS. 150/- AND REGISTRATION FORM SHOULD BE SENT THROUGH RESPECTIVE STATE RIFLE ASSOCIATION/UNIT.

5. Team events will be conducted in National Rule (NR) Matches only. Teams can be formed by the shooters of same school and only one team consisting of three shooters per school will be allowed in each event. Final entry of three members of the team must be submitted latest by **17.00 hrs. on 02-10-2017 .**

6. Students below the age of 19 and 15 years of age as on 31.12.2017 will be treated as Junior and sub junior shooters respectively. Attested copy of date of birth certificate should be attached with the entry form.

7. Those shooters who are taking part in ISSF matches and are members of the Core Group are not allowed to take part in National Rule Matches.

8. Shooters who have taken part in International competitions are not allowed to take part in this Competition.

9. Shooters can take part in one category i.e. junior or sub junior. Individual and team medals will be awarded as under:-

1. 3 medals where there are a minimum of 4 entries
2. 2 medals where there are a minimum of 3 entries
3. 1 medal where there are a minimum of 2 entries
4. No medal in case there is a single entry

10. The competition will be conducted according to ISSF Rules and NRAI Match Book.

11. No arms will be provided to the competitors by NRAI. Air pellets will be made available against cash payment at the range.

12. All the students must be in their School uniform at the time of March Past in Opening/Closing and Prize Distribution Ceremony. Schools are requested to send their school Flags for March Past during Opening/Closing Ceremony.

13. The details/lanes would be allotted in the name of State Rifle Associations and not to individual shooters. All the participating States/Unit should officially nominate a Team Manager for the championship and he should ensure that details/lanes allotted to state/unit are allocated to the shooters without any inconvenience. The Team Manager or his/her authorized representative only will attend the Managers meetings, submit protests, if any, and be sole in-charge of day-to-day affairs of the team concerned. Scoring protest can be lodged by the concerned shooters also.

14. Matches in Open Sight Air Rifle have been deleted from the program of this Championship.

10). ***I understand that entry form must be duly complete in every respect along with entry fees BY DEMAND DRAFT ONLY and must reach MRA office on or before 4.00pm on 04/09/2017.*** NO ENTRY FORM WILL BE ACCEPTED AFTER THE 04/09/17. HOWEVER IF THE MRA IS CONVINCED OF THE GENUINNESS OF THE DELAY, IT MAY ACCEPT SUCH LATE ENTRY FORMS WITH THE LEVY OF A NOMINAL PENALTY OF RS. 100/- PER SHOOTER UNTIL 07/09/17 AND WITH THE UNDERSTANDING THAT IN CASE OF LATE RECEIPT OF SUCH ENTRY BY THE NRAI, IT WILL BE THE SOLE RESPONSIBILITY OF THE SHOOTER TO PAY TRIPLE ENTRY FEE TO THE NRAI. ENTRY FORMS WITH TRIPLE ENTRY FEES MAY BE FORWARDED TO THE NRAI WITH LEVY OF RS. 200/- AS LATE FEE, AT THE SOLE RESPONSIBILITY OF THE SHOOTER. ***(I understand that three times of the normal entry fee along with entry form duly complete in every respect must reach MRA office on or before 4.00pm on 11/09/2017)***

11). **A shooter who puts in his entry for an event for which he is not eligible will be solely responsible and will be liable for severe disciplinary action.** Shooter must fill the entry form in his own handwriting. Incomplete entry forms will be rejected. Collection of the entry form by the MRA office does not mean that on further inspection the form will not be rejected. Shooters furnishing incorrect information/statement/declaration shall be debarred from taking part in any Championships for a period of 2 years.

2. Shooters who have applied for NRAI ID card but have not received the same: must attach one passport size photograph, with name and state written at the back of the photograph and birth certificate for junior & youth category.
3. Shooter must fill the entry form in his own handwriting. Incomplete entry forms will not be accepted and shall be rejected. Shooters furnishing incorrect information /statement/ declaration shall be debarred from taking part in any Championships for a period of 2 years.

Blue Jeans will not be permitted during the competition and award ceremony. All clothing / shoes during competition must strictly adhere to the ISSF Rules. Shooters must be dressed in formal attire for all prize ceremonies.

SHOOTERS DECLARATION CUM UNDERTAKING

- I understand that I will be participating in the XXI All India Kumar Surendra Singh Inter School Shooting Championship, to be held at Varanasi, from Maharashtra and will conduct myself in a manner of highest discipline and sportsman spirit. My behavior on and off the field at the competition site and the travel thereof shall be of utmost discipline.
- That If I intend to use any of the MRA's match weapons at the event, I must complete all requisite formalities in writing well in advance (at least 7 days) by personally visiting MRA's office at Mumbai failing which I will not be allowed to use MRA's weapon in the competition.
- That I shall inform MRA office of my travel plan in detail intimating train / flight no., time of departure, time of arrival at venue, hotel name and address + telephone number and mobile number. It is my responsibility to keep the manager informed of change, if any.
- I understand that it is MRA's policy to give priority to higher ranking shooter to choose detail & lane numbers, however, manager has the discretion to relax this policy. Allotment of details and lanes is done at the Managers meeting which normally takes place in the evening every day at the competition venue. It is my responsibility to keep myself informed about the timing and exact place of the meeting by keeping in touch with the manager. I undertake to attend all such meetings and obtain detail number and lane number which are allotted to me in writing by the Manager and / or Dy. Manager(s) on my competitor card.
- I understand that no shooter of Maharashtra shall occupy any lane of any detail allotted to Maharashtra State unless and until s/he has been allotted that particular lane and detail number in writing by the manager on shooters competitor card. I undertake to occupy only the lane and detail which is allotted to me with endorsement of such allotment on my competitor card.
- I understand that team entries are to be submitted one day before the beginning of particular event. I must be physically present in town and must appear before the manager before 3pm failing which my name will be removed from the team entry and team will be formed with next ranking shooter who is physically present and available at the competition site
- I will be present for and dressed in the tracksuit issued by MRA for all prize distribution ceremonies WITHOUT FAIL and will accept my medals personally. In case I am unable to do so for reasons beyond my control – I will take prior permission from the manager justifying my absence from the victory ceremony. Absence of medal winners at the time of victory ceremony is viewed as very serious indiscipline act and shooter is liable for serious disciplinary action.
- During competition I will conduct myself in accordance with the ISSF / NRAI rules. I will not in any way use any unfair means to increase my scores. I understand that in the case that I am found guilty of cheating/using unfair means I will accept the verdict of the NRAI and / or MRA.
- In the event of breach of any of the above conditions, I am liable for the disciplinary action and the decision taken by the Manager on the spot, in this regard shall be final and binding upon me which will not be challenged by me.
